In order to earn the Powder Horn award medallion, participants must attend at least 10 electives, and will meet expert consultants in our area who will be providing the program. **This course is perfect for:** Venturing Leaders & Sea Scout Leaders, Boy Scout Leaders & Commissioners, District, Council Leaders/Professional Staff, and Youth must be age 14 (or have joined a Venturing crew if 13 and finished 8<sup>th</sup> grade) and completed their unit's version of Leadership Training (Introduction to Leadership Skills for Troop or Introduction to Leadership Skills for Crew)

**Participant Qualifications:** All adults & youth must be registered members of the Boy Scouts of America and must have completed **Venturing Youth Protection** and Hazardous Weather on line through myscouting.org, the e-learning section of Training. Adults must have completed Leader Specific Training for their position. More pre-course training on line may be required, prior to the course. Be able to meet physical requirements in the Annual Health and Medical Record for backcountry environment.

**Course Size:** The course is limited to **no more than 48** participants. Once the course is filled, you will be placed on a waiting list in case of cancellations. We will likely have out of council participants, so sign up early as this course will likely fill up fast!
